

**Diversified Vocational College Higher Education Emergency Relief Fund Under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) and American Rescue Plan Act, 2021 (ARP)**

**Student Funds Quarterly Report**

**Updated January 15, 2022**

The following report covers the time period between: April 1, 2021 and June 30, 2021.

1. Diversified Vocational College signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.
2. The total amount of funds that Diversified Vocational College will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs is \$1,418,034.
3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of June 30, 2021 is \$686,362.
4. The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs is 154.
5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs is 396.
6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs is as follows.

Diversified Vocational College has chosen to implement the CRRSAA Emergency Assistance Grant by providing an award to eligible students. The grant may be awarded more than once, but no more frequently than once per calendar month. This grant requires an application to be submitted by the student. The applicant will be subject to eligibility requirements established by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021, by the Department of Education, and by Diversified Vocational College.

Diversified Vocational College will allow students to apply for a CRRSAA Emergency Assistance Grant, once per month. The value and monthly application limit is established in consideration of the modular nature of the Schools' training programs, as well as the varying length of the training programs. A monthly opportunity to apply will ensure that the greatest number of students are assisted, in an equitable manner.

Students in need of financial assistance in any given calendar month must submit an application in order to receive the grant. One application may be submitted by any individual student per month. CRRSAA funds are limited; therefore, submission of an application for the CRRSAA Emergency Assistance Grant does not guarantee issuance or receipt of grant funds, and the value of the award may be changed at any time based on the availability of funds.

CRRSAA Emergency Assistance Grant Eligibility Requirements:

- Submission of an application for each CRRSAA Emergency Assistance Grant.

Diversified Vocational College will require an application in order to ensure that funds are reserved for individuals who are in need of financial assistance. Only one application may be submitted by an individual per calendar month. The application includes an acknowledgement that, in accordance with 314(d)(7) of the CRRSAA, the funds are intended for use towards the "cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care."

- Applicants must be active students, enrolled in a training program at Diversified Vocational College.
- Students may receive a CRRSAA Emergency Assistance Grant no more than once per calendar month.

All instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants consist of a policy overview, provided to all students ("Diversified Vocational College CRRSAA Grant Funds for Students"), an application for the grant ("CRRSAA Emergency Assistance Grant APPLICATION"), and a receipt ("STUDENT RECEIPT ACKNOWLEDGEMENT") issued to all students upon receipt of a grant check. **Diversified Vocational College CRRSAA Grant Funds for Students**

The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) has made funds available to assist students experiencing hardship caused by the Coronavirus. These funds will be issued to students through financial aid grants to students. These funds are intended to be “used for any component of the student’s cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.”

The grant funds are held by Diversified Vocational College in trust; the School acts as a fiduciary for students. As such, DVC has been granted discretion to determine the amount and availability of the financial aid disbursements to students.

Diversified Vocational College does not condition the receipt of, or eligibility, for the CRRSAA Grant Funds for Students on continued or future enrollment with Diversified Vocational College or other Diversified Education Company owned institutions. Additionally, Diversified Vocational College does not condition the receipt of the CRRSAA Grant Funds for Students on application of the grant funds towards any outstanding tuition balance with Diversified Vocational College or other Diversified Education Company owned institutions.

CRRSAA Emergency Assistance Grant

Diversified Vocational College will offer a “CRRSAA Emergency Assistance Grant” to eligible students. The December 27, 2021 CRRSAA requires that institutions prioritize students with exceptional need, such as Pell grant recipients, in awarding financial aid grants to students. Diversified Vocational College has chosen to implement the CRRSAA Emergency Assistance Grant by providing an award to eligible students. The grant may be awarded more than once, but no more frequently than once per calendar month. This grant requires an application to be submitted by the student. The applicant will be subject to eligibility requirements established by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021, by the Department of Education, and by Diversified Vocational College.

The Department of Education has indicated that further guidance on the eligibility requirements of the CRRSAA funds will be issued in the future. Therefore, the eligibility requirements listed herein are subject to change.

Use of Funds

All CRRSAA grant student funds are intended to assist students pay “for any component of the student’s cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.” The funds will be made available to students in the form of a check. At this time, students are not required to document or report the manner in which they used the funds.

Tuition

The CRRSAA regulations make special mention of the use of the CRRSAA funds for tuition. If a recipient of one of Diversified Vocational College’s CRRSAA grant awards elects to do so, they may apply the grant funds awarded to them to pay for tuition. Those wishing to apply the funds towards tuition must indicate their wish to do so in writing, by signing and dating the portion of their application dedicated to this purpose.

The application of the CRRSAA grant funds is an optional use of the funds, made at the sole discretion of the recipient. Recipients have the right to receive a direct disbursement of the financial aid grant, in whole or in part. Furthermore, Diversified Vocational College does not condition the receipt of the CRRSAA Grant Funds for Students on application of the grant funds towards any outstanding tuition balance with Diversified Vocational College or other Diversified Education Company owned institutions.

If an applicant for one of the Diversified Vocational College’s CRRSAA grant funds elects to apply their funds to their tuition, they will be required to indicate this on their application, signing and dating a second time to indicate their intention and acceptance.

Grant funds applied by the recipient to their tuition balance will be directly credited to their account by the School. The balance of any grant funds will be issued in the form of a check to the recipient. The total grant amount awarded, the amount to be applied to tuition, and the balance to be issued directly to the recipient shall be indicated and acknowledged by the recipient on the application form.

Note: It should be noted that the Department of Education has indicated that further guidance on the management, use, and eligibility requirements of the CRRSAA may be issued. As such, this document and all of the guidance and requirements within are subject to change.

The CRRSAA Emergency Assistance Grant is a grant award derived from funds issued by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021. Diversified Vocational College offers this award to students meeting the eligibility requirements who apply for it. Students in need of financial assistance in any given calendar month must submit this application in order to receive the grant. One application may be submitted by any individual student per month. As CRRSAA funds are limited, submission of an application for the CRRSAA Emergency Assistance Grant does not guarantee issuance or receipt of grant funds, and the value of the award may be changed at any time based on the availability of funds.

**Eligibility Requirements**

1. Submission of this application for each CRRSAA Emergency Assistance Grant.
2. The student must be an active student, enrolled in a training program at Diversified Vocational College.
3. Students may receive a CRRSAA Emergency Assistance Grant no more than once in a calendar month.

**Use of funds**

The funds are intended for use towards the “cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.” Recipients are not required to report their use of the funds, at this time.

**Tuition**

At the sole discretion of the applicant, funds from CRRSAA grant awards may be directly paid towards outstanding tuition balances with the School. Those wishing to apply the funds towards tuition must indicate their wish to do so in the section below in writing, by signing and dating the portion of their application dedicated to this purpose. Application are hereby notified that any application of CRRSAA grant funds towards tuition in any form is optional, and the decision to do so or not to do so has no bearing on the applicant’s eligibility for or receipt of the grant funds. Applicants are further notified that they retain the option to receive a direct disbursement of the CRRSAA grant funds.
