## **STUDENT RIGHT TO KNOW**

The Student Right-to-Know Act (Publ. 105-18) requires schools to disclose information about graduation rates to current and prospective students and the public. The Right-to-Know regulations defines the reporting period to be based on starting July 1<sup>st</sup> and ending June 30<sup>th</sup> of each year.

Diversified Vocational College, Los Angeles and Los Angeles Branch, in complying with the students Right-to-Know Act, discloses the following graduation rates for the enrollment period of July 1, 2017 through June 30, 2018 for the Business Office Administration, Medical Billing Electronic System, and Transportation and Logistics programs.

The school enrolled Ninety six (96 = 100%) students in its **Business Office Administration** program. Sixty five (65 = 68%) students completed their training within 150% of the normal time to graduate. The remaining Thirty one (31) students either did not graduate or did not complete within the 150% of the normal time to graduate.

The school enrolled Ninety nine (99=100%) students in its **Transportation and Logistics Technology** program. Sixty three (63 = 64%) completed their training within 150% of the normal time to graduate. The remaining Thirty six (36) students either did not graduate or did not complete within the 150% of the normal time to graduate.

The school enrolled Forty-two (42 = 100%) students in its **Medical Billing Electronic System** program. Thirty (30 = 71%) completed their training with 150% of the normal time to graduate. The remaining Twelve (12) students either did not graduate or did not complete with the 150% of the normal time to graduate.

Diversified Vocational College, Los Angeles, in complying with the students Right-to-Know Act, discloses the following graduation rates for the enrollment period of July 1, 2017 through June 30, 2018 for the Vocational English as a Second Language (VESL) program.

The school enrolled Sixty four (64=100%) students in its **Vocational English as a Second Language** program. Thirty five (35=55%) completed their training within 150% of the normal time to graduate. The remaining Twenty nine (29) students either did not graduate or did not complete within the 150% of the normal time to graduate.
